What is Resilient SRQ?

Resilient SRQ is Sarasota County's program for its allocation of Community Development Block Grant-Disaster Recovery (CDBG-DR) funds from the U.S. Department of Housing and Urban Development (HUD). CDBG-DR program funds must be used to address an impact from a declared disaster and be an eligible activity linked to disaster relief, long-term recovery, infrastructure and housing restoration, and economic revitalization.

Programs must:

- Benefit low-to moderate-income persons, have an urgent need or prevent or eliminate blight.
- Have a "tie back" to the disaster or respond to an unmet need arising from that disaster, unless using the 15% mitigation set aside that does not need a "tie back" to the disaster.
- Have a least 70% of funds benefit low-to moderate-income persons.

Action Plan Development

In order to receive funds from HUD and authorize programs and projects for implementation, Sarasota County was first required to complete a planning process and develop a **CDBG-DR public action plan**. The action plan is a summary detailing how funds will be allocated to address the county's remaining unmet needs. Throughout this process, Sarasota County reviewed data from local, state and federal sources, and gathered input from the community through surveys, public meetings and outreach, which included:

- **1,480 survey respondents** from organizations and individuals
- **4 public input meetings**
- **6 governmental entities**
- **6 presentations to community groups** representing more than 100 organizations
- **3 Sarasota County Commission meetings**
